### **Appendix 4C – Quarterly cash flow report**

Aquis Entertainment Limited ACN 147 411 881 (**Aquis** or the **Company**) (ASX: AQS) attaches the Appendix 4C Quarterly cash flow report for the quarter 1 October 2020 to 31 December 2020.

#### **Business activities**

Aquis' ordinary business activities are the operation of Casino Canberra, incorporating Natural Nine restaurant.

This is the first full quarter's trading after the re-opening of Casino Canberra on 10 August 2020 following the ACT Government's mandated shut-down as part of their Covid-19 restrictions. During the quarter, the business continued to comply strictly with the Government's trading restrictions.

Despite operating at a reduced capacity under the restrictions, all operational employees have returned to their pre-shutdown working hours. Business revenues were strong throughout the quarter and net operating cash flow is also positive.

#### **Expenditure**

Total expenditure during the quarter on business activities totalled \$7.741m which includes \$3.907m in gross payroll expenses (pre JobKeeper subsidies) and \$3.834m in other operating expenses.

Government grants and tax incentives received was mainly from the reimbursements for Jobkeeper wage subsidies by the Australian Federal Government.

#### **Related party transactions**

Total payments made to related parties included in the above expenditure, during the quarter was \$2,136,000.

These payments include non-executive director's fees to Mr Alex Chow, Mr Russell Shields and CEO/executive director's salary to Ms Allison Gallagher (JobKeeper subsidised) as well as a repayment of borrowings. No other related party transactions occurred during the quarter.
