

The loan is unsecured and interest accrues at the lower of (a) BBSY plus 2% per annum; and (b) the RBA indicator lending rate for small business; variable, residential secured and term rates. Further detail in relation to these loan arrangements was provided to shareholders of the Company in the notice of annual general meeting on 29 April 2016.
