Appendix 4C – Quarterly cash flow report

Aquis Entertainment Limited ACN 147 411 881 (**Aquis** or the **Company**) (ASX: AQS) attaches the Appendix 4C Quarterly cash flow report for the quarter 1 April 2022 to 30 June 2022.

Business activities

Aquis' ordinary business activities are the operation of Casino Canberra, incorporating Natural Nine restaurant.

Covid-19 disruptions continue to impact on the Casino workforce; however, business revenues remain strong for the quarter ended 30 June 2022 and continue to exceed the budgeted EBITDA.

The Casino's Covid-19 Safety Plan remained in place and was maintained up to date in accordance with the ACT Public Health Direction.

Aquis recently announced the proposed sale of Aquis Canberra Pty Ltd (Aquis Canberra), a wholly owned subsidiary of the Company, which owns and operates Casino Canberra and is Aquis' only business undertaking. Iris CC Holdings Pty Ltd (**Iris**) will acquire 100% of the shares in Aquis Canberra for A\$63m, plus or minus customary completion adjustments (the **Transaction**). A deposit of \$2.5m towards the Transaction value has been received by Aquis. The balance of the \$63m purchase price is held in Escrow by Aquis' legal representatives.

The Transaction remains subject to shareholder approval, recommendation by the independent directors and successful completion of probity review of Iris by the ACT Government.

The Board of Aquis is currently considering the use of the sale proceeds, including repayment of outstanding debt and distribution to shareholders, amongst other options. The Board is also considering the future of Aquis and further details on these matters will be sent to shareholders in due course.

There were no other substantive business activities during the quarter.

Expenditure

Total expenditure during the quarter on business activities totalled \$7.461m which includes \$4.272m in payroll expenses and \$3.189m in other operating expenses.

Capital expenditure totalled \$155k for the quarter.

Related party transactions

Total payments made to related parties included in the above expenditure, during the quarter was \$155,000.

This expenditure represents non-executive directors' fees to Mr Russell Shields and Mr Mark Purtill, as well as the CEO/executive director's salary to Ms Allison Gallagher.

A further repayment of principal on the finance facility totalling \$2.5m was made to the group's financier Aquis Canberra Holdings Pty Limited, which is also the group's major shareholder.

No other related party transactions occurred during the quarter.
